Author Guidelines: Article submitted for publication have to check to the following guidelines:

1. Papers should discourse the themes of law in general, including legal theory, legal philosophy, constitutional law, legal debate, socio-legal, human rights, international law, court and justice, sharia law, constitutionality of parliamentary products, law and politics;
2. All articles must be written in British English or American English;
3. Article must type in one-half spaced on A4-paper size, using Cambria font 12;
4. Papers length is about 5,000-10,000 words, insufficient word count will reject automatically;
5. All submission must include a 150-200 words abstract written British English or American English;
6. All submission must have file in OpenOffice, Microsoft Word, RTF, or WordPerfect document file format;
7. Full name(s) of the author(s) must be stated, along with his/her/their institution and complete address;
8. In the matter of writing citation and bibliography, PETITA follows the Oxford University Standard for the Citation of Legal Authorities (OSCOLA) manual style. A citation requires the name of the author(s), title, edition, publisher, year and page number.
